MEETING MINUTES

SHAVER LAKE CITIZENS ADVISORY COMMITTEE October 6, 2016

Call to Order: Meeting started at approximately 2:00 pm

Agenda Item 1: Review and Approve Minutes from the July 28, 2016 Meeting

The minutes for the previous meeting were approved.

Agenda Item 2: WWD 41W Asbestos Project Update

Mr. Strahm opened the conversation by discussing the advantages and disadvantages of PVC, HDPE, and ultra-high molecular weight polyethylene. He stated that a decision has yet to be made as to which type of pipe will be used. The decision will be made once construction costs are calculated and pipe material costs are compared. He went on to question the possibility of keeping existing A/C pipe to fire hydrants in place however the point was made that the asbestos has the potential to plug fire engine filters therefore all potentially deteriorated A/C pipe in the affected area should be removed. Mr. Strahm brought up the possibility of having to temporarily provide water service to existing parcels as construction proceeds. Options provided to establish this temporary connection included a 1½ inch poly pipe laid above ground in incremental sections while assuring fire hydrants remain active. Mr. Strahm indicated that the cost for a temporary water connection could reach as high as \$175,000.

Agenda Item 2: Project Assessment Options

A discussion was had regarding the different assessment options that may be taken to ensure an adequate amount of funds are available for the project and to re-build the District's reserve to a sufficient level over the course of ten years. Several options were presented to the CAC which included options for a one-time initial assessment. The decision was made to forgo loan

funding from the State Revolving Fund as well as the one-time initial assessment and to use the District's current reserves in conjunction with a Proposition 218 to fund the project and rebuild the District's reserves. The District chose the option shown below however the initial one-time assessment will be removed and will be added onto this option while being spread out over the course of ten years. The proposed annual assessment may be modified as the project is further refined.
